PROPERTY TAX BILL

To levy and impose a property tax for the use of Baltimore County for the taxable year beginning July 1, 2026 and ending on the 30th day of June following and to fix the rate of County taxation for such taxable year at \$1.10 on each \$100.00 of assessed valuation of such property and to fix the rate of county taxation for personal property at \$2.75 on each \$100.00 of assessed valuation of such property.
