AN ACT concerning

The 2025-2026 Current Expense Budget
Gifts and Grants Special Revenue Fund
Health Management Associates Grant

FOR the purpose of amending the 2025-2026 Current Expense Budget, by appropriating to the Gifts and Grants Special Revenue Fund monies derived from state funds and made available to the County through the Governor's Office of Crime Prevention and Policy.

WHEREAS, the Governor's Office of Crime Prevention and Policy has made an award of state funds available to the Baltimore County Department of Corrections, to be used to improve behavioral health treatment and services through evidence-based strategies. Health Management Associates will provide coaching and consultation in three specific areas. Access to evidence-based screenings, assessment and treatment. Strengthen cross-system coordination with community providers and re-entry partners. And, assistance with integrating treatment for co-

occurring disorders. Baltimore County Corrections is eligible for a stipend of up to \$35,000 for participation in the program; and

WHEREAS, in accordance with Sections 306 and 712(a) of the Baltimore County Charter and Section 10-6-102 of the Baltimore County Code, 2015, as amended, the County Council may accept gifts and grants, appropriate same to the Gifts and Grants Special Revenue Fund and expend the same, said fund having been established solely for the purpose of accounting for certain monetary gifts and grants made available to the County for restricted purposes; and

WHEREAS, such fund remains open perpetually as a mechanism to account for the respective gift and grant appropriations and expenditures throughout the entire term of the grant period, including beyond the current expense budget fiscal year; now therefore

1 SECTION 1. BE IT ENACTED BY THE COUNTY COUNCIL OF BALTIMORE
2 COUNTY, MARYLAND, pursuant to the power and authority conferred upon it by Sections 306
3 and 712(a) of the Baltimore County Charter and Section 10-6-102 of the Baltimore County
4 Code, 2015, as amended, that the Current Expense Budget for the fiscal year ending June 30,
5 2026, be and is hereby amended by appropriating state funds made available to the Baltimore
6 County Department of Corrections, in the amount herein specified, to the following program:

9 SECTION 2. AND BE IT FURTHER ENACTED, that this Act, having been passed by
