A RESOLUTION of the Baltimore County Council concerning the Baltimore County Board of Education and the authorization for expenditure of nonlocal funds.

WHEREAS, pursuant to § 5-105(c) of the Education Article of the Annotated Code of Maryland, the Baltimore County Board of Education (the “Board”) is required to notify and seek the County Council’s approval to expend nonlocal funds by or on behalf of the Board after the adoption of the annual budget ordinance by the County Council; and

WHEREAS, pursuant to § 5-105(c) of the Education Article, the County Council must authorize the source, amount, and manner of spending of such nonlocal funds; and

WHEREAS, the Board has notified the County Council of its request to utilize nonlocal funds for Fiscal Year 2026 through the use of additional fund balance and has requested the County Council’s approval to spend such funds in a specific manner; now therefore

BE IT RESOLVED BY THE COUNTY COUNCIL OF BALTIMORE COUNTY, MARYLAND, under the authority provided to it by the Education Article of the Annotated Code of Maryland, that the County Council has received notice of and does hereby authorize the Baltimore County Board of Education’s request to expend the following nonlocal funds received by the Board through the use of additional fund balance in the following manner:
